

Overview

The meeting featured Jeff as the primary speaker and Clayton assisting with technical aspects of the Webex platform. The session focused on deepening the understanding of complex prophetic themes, particularly the progressive revelation of the midnight cry message since 2023. Jeff elaborated on the hidden history in Daniel 11 and its alignment with modern political and religious developments, including the judgment of the living beginning at 9/11 and culminating in the Sunday law. He emphasized the prophetic significance of the U.S. political parties as the two horns in prophecy, detailing their sequential judgment and the formation of the image of the beast through the union of apostate Protestantism and Republicanism. Historical events such as the battles of Raphia and Panium and the Maccabean revolt were interpreted as prophetic types foreshadowing current end-time realities. The discussion underscored the necessity of faith and perseverance in embracing the prophetic message amid testing, with the sealing of the 144,000 contingent upon recognizing and passing the final tests. Technical challenges with the Webex platform were managed with assistance, and the meeting included prayers for spiritual guidance and clarity. The session concluded with a call for continued development and dissemination of the prophetic message globally through accessible digital means.

Detailed Summary

Revelation 17 Interpretation

The discussion addressed questions about the interpretation of Revelation 17, highlighting the progressive development of understanding over the years. The speaker noted that earlier presentations might lack recent insights and emphasized the connection between the Millerite movement and the history of the first and second angels, contrasting it with the movement of the 144,000 associated with the third angel. The threefold union of modern Rome was identified as a key prophetic element unsealed in 1989.

- Jeff explained that Revelation 17's understanding has grown over time and earlier presentations may lack newer insights.
- He connected the Millerite movement to the first and second angels and the 144,000 movement to the third angel.

Two Witnesses Resurrection Timeline

Clarification was provided regarding the timeline of the resurrection of the two witnesses, explaining that the process began progressively in July 2023 and continued into 2024. The speaker described the 1260 days as a period starting in July 2020 and ending December 31, 2023, with the resurrection process beginning at the end of 2023 or start of 2024. This progression is part of the prophetic narrative and involves a three-step testing process culminating in the selection of the 144,000.

- Jeff clarified that the resurrection of the two witnesses began progressively in July 2023 and continues into 2024.
- He described the 1260 days from July 2020 to December 31, 2023, as the period of the two witnesses being slain.
- The resurrection process involves a three-step testing culminating in the 144,000.

Progressive Prophetic Message Development

The meeting emphasized the progressive nature of the prophetic message, noting that new insights have been revealed over time through resistance and testing within the Adventist community. The speaker recounted historical opposition from both self-supporting ministries and the General Conference, highlighting the challenges faced in advancing the message. - Jeff explained the midnight cry message is progressively revealed and central to end-time prophecy.

Prophetic Symbolism of Historical Events

He interpreted these as symbolic of political and religious alliances, the formation of the image of the beast, and the Sunday law. The discussion included parallels between ancient and contemporary figures and events, emphasizing the continuity and fulfillment of prophecy through history.

- Jeff linked the battles of Raphia and Panium to proxy wars involving the U.S. and Russia.
- He identified the Maccabean revolt as typifying apostate Protestantism's role in end-time prophecy.
- The rededication of the Jewish temple parallels the rededication of the U.S. as a Protestant nation.
- These historical events symbolize alliances forming the image of the beast.
- The Sunday law is typified by events around 63 BC and the culmination of these prophetic lines.
